## **Purpose for the code of conduct:**

- To support a safe and enjoyable environment for all members of our Youth Group.
- To provide clear and explicit expectations for social behaviors in all Youth Group settings.
- Provide leaders, students, and staff with appropriate actions that address student behaviors.

## Policy regarding behavior:

Our Code of Conduct rules, and expectations are for all students, leaders, and pastors in church and youth group events and activities. These are common sense expectations built on respect for each other as brothers and sisters in Christ. It follows, therefore, that students and leaders must refrain from disrespecting one another, from offensive and abrasive language (or dress), violence against others, from bullying, harassment, carrying any sort of weapons and use of drugs or alcohol. Consequences for students who endanger the youth group and church safety or disrupt the overall youth group experience of others will be handle on an individual basis. This code of conduct applies during youth group on and off-site events. It also applies while on the way to and from youth group, (church vans, the shuttle, or private forms of transportation). Families and guardians are critical to our youth group and church community. We ask that you please read and understand the Code of Conduct and discuss them with your child(ren). We at Bethel Baptist Church understand that you, the parents, and guardians, know the best way to make sure your child(ren) understand the expectations that will lead to a safe and orderly church community. This Code provides definitions of behavioral offenses.

Pastor Ben will be brought in and made aware of any disciplinary action needing attention.

Parents, guardians, and caregivers who have any questions or concerns are encouraged to contact Pastor Jude @ Bethel Baptist Church.

## **Behavioral Expectations and Responsibilities:**

### Responsibilities for everyone:

- Respect all members of the youth group and church.
- Maintain a positive climate by being responsible, and cooperative.
- Communicate Code of Conduct expectations for students and staff.
- Motivate students to live up to the expectations of Jesus Christ and the church through positive reinforcement.
- Use good judgment to prevent minor incidents from becoming major problems.

### **Responsibilities for leaders:**

- Respect all members of the youth group and church.
- Be fair and consistent in disciplinary procedures.
- Inform Youth Staff of all disciplinary actions.
- Use wise judgment to prevent minor incidents from becoming major problems.
- Teach and exhibit godly behavior and positively reinforce rules of conduct.
- Maintain a healthy and positive large/small group and atmosphere to provide spiritual growth
- Hold students accountable for their walk with God.

## **Responsibilities for Students**

- Respect all members of youth group and the church community as you would like to be treated.
- Understand and comply with youth group rules and expectations.
- Behave in a godly manner that focuses on spiritual growth
- Be responsible and accountable for the rules stated in this Code of Conduct
- Cell phones will be picked up on all out-of-town trips and keep with Pastor Jude.
- During Bible studies cell phones are to be turn off and placed in cell jail till the end of Bible study.

Cell Phones: students will have access to any leader's cell phone if needing to make a call to parents for any reason.

## Responsibilities of Parents / Guardians

- Respect, understand and support all leadership and policies of the Bethel Baptist Church youth group
- · Recognize and understand that youth leaders and personnel must enforce the code of conduct.
- Teach your children to respect the rights of others and to follow youth group rules.
- Emphasize the importance of being a model person in both the home, the church, and in the community!

# **Modesty Guidelines**

These modesty guidelines have been put in place to ensure all youth dress in a modest and appropriate manner for all youth activities. The parent/guardian is responsible to see that the modesty guidelines are followed while engaged in all youth activities and outings. These guidelines include the following:

In general, revealing, or suggestive clothes are not becoming of a Christian, therefore are not permitted at any youth gathering.

- Shirts that are strapless or that reveal bare back or bare stomach should not be worn.
- Underwear should be worn under your clothes (not to be seen, either above your pants waist or through your shirt).
- Females Two-piece swimsuits should only be worn with shorts and a swim shirt. In the case of a one-piece or tankini suit, only shorts are required.
- Guys Wear a swim shirt with swim trunks or board shorts. NO speedos are acceptable. If a tank top is worn, there should be no gaping sides.
  - Male & female Shorts should be appropriate length.
- No offensive language or images on clothing, including hats, etc., including alcohol or drug advertisements.
- Some activities may require a stricter dress code, these will be communicated in advance.
  - If clothing is deemed inappropriate, a same sex youth leader (male/male, female/female) will address the matter in a way that is respectful and not embarrassing. At this time, the parent of the youth will be notified.

# **Biblical Background for Modesty**

The church is the body of believers brought together by the shed blood of Jesus Christ. The moment God saves us, He adopts us into His family of faith, the church. The focus of the church is to continue the work of Christ until He returns. A good snapshot of the church can be found in Acts 2.42:

They were continually devoting themselves to the apostles' teaching and to fellowship, to the breaking of bread and to prayer.

When we gather for worship or other church activities, the focus must always be the glory of God. When attention is drawn to us it is drawn away from God and that should never be the focus of our gathering.

From the beginning, God ordained that clothing is important for man and woman.

<u>Gen. 3.7</u>: Adam and Eve, once aware of their nakedness because of their disobedience, "sewed fig leaves together and them themselves loin coverings."

Gen. 3.21: The Lord God made garments of skin for Adam and his wife and clothed them.

God made garments for Adam and Eve because what they thought were good enough was not acceptable to God.

<u>Prov. 31.25</u>: [speaking of the worthy woman, although she makes coverings for herself of fine linen and purple and makes linen garments] Strength and dignity are her clothing.

JAS. 2.2-4 [READ]: clothing can cause distinctions and distinctions become distractions

 $\underline{1\ PET.\ 3.3-4}$  [speaking of wives, but do not misunderstand what Peter is teaching here] Your adornment must not be merely external braiding the hair, and wearing gold jewelry, or putting on dresses; but let it be the hidden person of the heart, with the imperishable quality of a gentle and quite spirit, which is precious in the sight of God.

The core issue here in all these verses is the honor of God.

In the Book of 1 Timothy, the apostle Paul addressed the issue of clothing. Clothing had become an issue because wealthy church members could dress in a manner others could not and that was taking away from the worship of God. Paul wrote to the young pastor Timothy:

<u>1 Tim. 2.9-10</u>: likewise, I want women to adorn themselves with proper clothing, modestly and discretely, not with braided hair and gold or pearls or costly garments, but rather by means of good works, as is proper for women making a claim to godliness.

The background for this verse of Scripture concerns the lifestyles of the city of Ephesus. Ephesus was one of the largest cities of the world in Paul's day, a very cosmopolitan city devoted to the worship of the goddess Diana. In fact, one of the seven wonders of the ancient world was located in Ephesus, the temple of Diana. The Ephesian church was comprised of both Jew and Greek, and some in the church had come from a culture of idolatry and immoral living. Paul had noticed that the culture of the city had infiltrated the church. Some wealthy church members were flaunting their wealth in terms of how they dressed, while others were not able to; this caused division in the church and took away from the worship of God. Paul wanted to teach this young pastor Timothy that outward appearance, whether male or female, should never distract from the worship of God.

Key words here:

ADORN: to decorate or garnish

MODESTLY: sensible, self-controlled, propriety of dress, grace and dignity both in dress and demeanor.

This same word is used in 1 Tim. 3.3 of overseers (good behavior) and means well-behaved, honorable as well as modesty and sobriety [of dress] $^1$ .

DISCRETELY: to revere what is good and to shun what is not

PROPER: suitable

The modest demeanor of the wife<sup>2</sup>.

Here are a couple of comments from scholars on this verse of Scripture:

[women] are as responsible for worship decorum as the men are<sup>3</sup>;

Dress that is not ostentatious but appropriate to the worship of God and Christ of whom Paul speaks so frequently in the Pastoral Epistles<sup>4</sup>.

Our good deeds [works] as Christian women [and men] are to call attention to God, not ourselves. Character, not clothing should identify us and promote proper corporate worship<sup>5</sup>.

It is the same spirit that Paul had with the church at Ephesus, the focus on God and not us, that these modesty guidelines are offered.

- No one is to stray from the group. In the event that someone becomes separated by accident, they must make every effort to immediately rejoin the group.
- Respect for and compliance for event/facility rules

Safe and moral conduct is mandatory for every participant at every event.

In the event the Youth herein named is dismissed from any activities planned/attended by/conducted by Bethel Baptist Church of Vandalia, Illinois, I agree to assume the cost of returning said Youth to his/her home. I further also agree to forfeit any possible refund.
