2. I hereby accept financial responsibility for any personal items lost by the persons identified herein and to indemnify Bethel Baptist Church against any claims resulting from the loss of such property.
3. I authorize Bethel Baptist Church to transport and to obtain, through a physician of its own choice, any emergency medical care that may become reasonably necessary for any person identified above in the course of such activities/events or such travel, and agree to be responsible for the cost of any such medical transportation and/or treatment by medical personnel or facility, and agree to indemnify Bethel Baptist Church against any claims resulting from such medical care or transportation.
4. I accept full responsibility and hereby grant permission for my child/children to travel on the bus which is driven by Bethel Baptist Church.
5. I understand that the privilege of riding the bus will be revoked due to misbehavior and/or not following the code of conduct as outlined on the back of this page. I have reviewed this code of conduct with the persons identified herein.

BETHEL BAPTIST CHURCH BUS RIDER CODE OF CONDUCT AND BEHAVIOR EXPECTATIONS

1. Show respect to the bus driver, bus volunteers, and other bus riders at all times.
2. Stay in your seat and keep your head, hands and feet to yourself at all times.
3. Seat belts shall be worn at all times.
4. No back-talking, name calling, or using foul language.
5. No fighting for any reason!
6. No yelling or screaming.
7. No throwing objects in or out of the bus.
8. No leaving any garbage on the bus.
9. **No Cell Phones (Elevate Kids only)**. Cell phones will be confiscated.

CONSEQUENCES

1. **1st Offense:** 2-week suspension from riding bus.
2. **2nd Offense:** Suspended from riding bus until a meeting with parent can be held.
3. **3rd Offense:** Permanent suspension from riding bus for the current Elevate Kids year.
